**Second Notice by Affidavit**

**Affidavit to Agent is Affidavit to Principal and Affidavit to Principal is Affidavit to Agent  
Notice of Affidavit**

I, \_\_\_\_\_, one of the people (as seen in Virginia Constitution Article I, Section 2) Sui Juris, in this Court of Record, bring the following claims and facts, that you and your agents may provide due care; Please take notice that our Virginia State Constitution, which you have already sworn to, explains that the People have the right to regulate their internal government, and therefore, when the people may need, there is a guaranteed right to reform, alter or abolish government. It is my will to give affidavit notice of the true law set forth by the people (see constitutional provision below):

**People the Source of Power  
Article 1, Section 2**

That all power is vested in, and consequently derived from, the people, that magistrates are their trustees and servants, and at all times amenable to them. Furthermore, the Virginia Constitution states for regulation of the Government.

**Government Instituted for Common Benefit  
Article 1, Section 3**

That government is, or ought to be, instituted for the common benefit, protection, and security of the people, nation, or community; of all the various modes and forms of government, that is best which is capable of producing the greatest degree of happiness and safety, and is most effectually secured against the danger of maladministration; and, whenever any government shall be found inadequate or contrary to these purposes, a majority of the community hath an indubitable, inalienable, and indefeasible right to reform, alter, or abolish it, in such manner as shall be judged most conducive to the public weal.

**This is an Affidavit of Notice and Contract and Change of terms**

Magistrates, their trustees and servants therein of the Commonwealth of Virginia, who denies these claims are true must rebut them under penalty of perjury in the form of a sworn affidavit. Any man or woman who decides to suppress this affidavit agrees to pay \$1,000 per day and any disputes by any public officials or private actors who are bound by contract to the Virginia Constitution agrees to have these matters heard before an Arbitrator of my choice. Any man or woman denying these claims are true must rebut these claims point by point within (3) days (72 hours). Failure to respond means that by acquiescence you agree that all claims are true. Failing to respond with constitutionally granted authority which gave you the power to disregard the people's rights mentioned within this Notice and Contract, means that you agree to have this notice used against you as evidence of Treason, Insurrection and Maladministration. You further agree that once the 3-day time period is up, this Affidavit becomes truth and law and that all matters must be considered adjudged and that no court has jurisdiction to rehear these matters and that these witnesses against you shall be considered sufficient for conviction.

Remedy shall be had by giving the people a full forensic audit of the 2020 election for the State of Virginia. The full forensic audit shall be completed by Cyber Ninjas or Jovan Pulitzer, or the choice of the people which shall include every in-person physical ballot, mail in ballot, absentee ballot, any machine used for voting, all associated software necessary to carry out an independent audit. These must also be protected and secured in a secure location of the auditor's choice.

Please take further notice that when government is functioning in a way that goes against the People's will and authority, the People are to correct their behavior and lead them in ways consistent with the constitution and that redress grievances.
